**AMENDMENT TO THE DECLARATION
FOR THE ADDITIONS COMPRISING RED CANYON RANCH, A
RESIDENTIAL COMMUNITY TO THE CITY OF NORMAN, CLEVELAND
COUNTY, STATE OF OKLAHOMA.**

THIS AMENDMENT is made this 24th day of September, 2015,
by Sweet Grass Communities, L.L.C., an Oklahoma limited liability company ("Declarant").

Section 1 - Purpose of Amendment.

Declarant is the Declarant of the Additions comprising Red Canyon Ranch which is a platted addition more particularly described within Exhibit "A" hereto. The Declarant intends by the Recording of this Amendment to amend and alter certain provisions of the Declaration filed at Book 4760, Page 281 (Original Declaration) within the Cleveland County Clerk's office for the several sections comprising Red Canyon Ranch, a residential community including any amendments and supplements thereto (Original Declaration). The Declarant executes and adopts this Amendment pursuant to its authority granted and reserved within the Original Declaration.

Section 2 - Amendment.

Section 4.13. "Fences" of the Initial Design Review Guidelines, filed as Exhibit "F" to the Original Declaration, is deleted in its entirety and replaced with the following:

4.13. **Fences.** Except as provided below, all fencing shall be constructed of 6 foot dog-eared wood stockade with the smooth surface installed facing outward to public streets, common areas, and any other open areas, developed or not. Any fencing facing Common Areas must receive DRB approval prior to installation. **For any corner Unit, no fence shall be constructed closer than twenty-one (21) feet from the street, as measured from the back of the curb to the base of the fence.** The fencing along the rear property line of lots and homes on the ponds, lakes and creeks contained within the Common Area will consist of a community standard four (4) foot tall split rail fencing with black vinyl-coated chain link product consistent within the development.

Section 3 - Additional Declarations.

All other terms and provisions, including but not limited to covenants, conditions, restrictions, definitions, and exhibits found within the Original Declaration and any amendments
